Energy-efficient home improvements—ones that can save you real money each month on your utility bills—qualify for federal tax credits and other local incentives. Central Communications Credit Union can help make your home a little "greener."

Federal tax credit

Reinstatement of tax credits for energy-efficient home improvements was part of the American Taxpayer Relief Act.

Congress made the tax credits retroactive, which means that improvements you made in 2012 and 2013 qualify. The program has a cap of \$500 in total credits and the improvements must be made to your principal residence. To make sure that the product you're purchasing qualifies for the energy credit, check the IRS website at irs.gov.

Tax credit vs. tax deduction

You've probably heard both terms, "tax credit" and "tax deduction." A tax credit is an actual dollar amount subtracted from the tax you may owe. A tax deduction decreases the amount of income that needs to be taxed.



So, the fact that energy-saving home improvements qualify for credits is an especially good deal for homeowners.

Energy audit

A good way to find out about green energy improvements is to conduct an energy audit. Your energy auditor may suggest upgrading appliances, replacing windows, adding insulation, or repairing leaks.


